2. Presentation: Two Rivers Greenway Trail Maintenance Plan, Scott Reigle

Scott Reigle presented on the Binghamton Metropolitan Transportation Study's report. Staff split the approximately 11 miles of trails into roughly 1/10th/mile segments to assign scores on the existing conditions. Pavements were rated one a 1-4 scale, and maintenance on a 1-3 scale. Major hazards were also noted, along with damage or issues with existing signage. The information in the report was provided directly to the municipal departments responsible for maintenance. Scott noted that staff intends to collect the data every two years.

3. Bike to Work, Walk and Roll to School Day, and Ditch the Car

Rima summarized this year's Bike to Work Challenge, which was on a Wednesday in June and had a new standings page to streamline team member tracking and recruitment. There were 275 participants in 33 teams. There was a popular "community team" option. A post-event survey and trophy and raffle winners will be posted this week.

This year "Bike to School" was changed to "Walk and Roll" to try to be more inclusive of different rolling modes, and it was held the same day as Bike to Work Day.

The second annual Ditch the Car Challenge has launched and will extend from June 4th to September 9th. The goal is to shift any trip for which people would otherwise drive their car into a trip via biking, walking, carpooling, or bus trips.

4. 2022-2027 TIP Update

Jen noted that the Planning Committee and Policy Board dates have changed. The Policy Board will meet on June 23rd and is expected to release the TIP for public review, which will extend from June 27th to August 12th. The Policy Board is then expected to finalize the TIP at its September 1st meeting. Jen provided an overview of the proposed funding summary, as well as each bike/ped beyond preservation project. explained that there have been additional delays of the TIP programming. Information that is now available includes candidate lists by project type, fact sheets, and federal funding allocations. CDTC will see a 13% increase as compared to the 2019-24 TIP, however after accounting for projects "rolling-in" to the new TIP, the increase will be approximately 3.3%. We received 19 bicycle and pedestrian project proposals. Jen provided an overview of each of them. Jen advised reading through the descriptions of each and submitting any comments to cdtc@cdtcmpo.org.

At the next Planning Committee meeting, multi-site and block funded projects and programs as well as site specific projects are expected to be proposed for funding, and a draft TIP is expected to be released for public review at the May 4th Planning Committee meeting. The June Policy Board meeting will be moved to June 16th to allow time for public review and to address any unforeseen issues.

5. Discussion items

a. Capital Coexist

The solicitation is currently open, with \$20,000 available for demonstration projects and \$15,000 for safety events led by local police departments.

Jen Ceponis referred to the table of ongoing projects and plans distributed with the meeting materials. Jen highlighted new projects.

6. News around the table

- Management of the Empire State Trail (EST) was transitioned to NYSOPRHP (Parks) in May 2022. This transition does not change ownership of the trail or the rules that apply jurisdiction still falls to the trail segment owner. Parks is looking at the next phase of the effort sustaining the trail. The main goals of Parks in this effort are communication, marketing and funding (when available). There shouldn't much of a change to stakeholders. There are new tools available on the EST website https://empiretrail.ny.gov/. 



About the 2021 Trail Maintenance Report



In the Summer of 2019, BMTS Staff released the Two Rivers Greenway Trail Maintenance Plan. This plan makes recommendations for maintenance of the trail sections that comprise the Two Rivers Greenway; it documents each trail in the system, including its infrastructure, needs, and plans for maintenance.


Within that plan, on-site trail assessments were performed to document each trail's design and usage, access and visibility, community attitudes toward the site, the site amenities, general site condition, corrective actions needed, planned capital improvements, and the strengths, weaknesses, and opportunities of the site.

The original plan detailed a need for conducting these site assessments every two years to ensure proper upkeep of the pavement and the trail surroundings. This 2021 report includes the basic updated assessment for pavement scores, maintenance condition, takes note of issues with signage, and any pressing corrective actions needed.

- Update to the 2019 Trail Maintenance Plan
- BMTS split the trails into roughly 1/10th mile sections. Using the ArcGIS Collector App, BMTS collected data on:
- Pavement: Scores range from 1-4. 1: Poor,
 2: Fair, 3: Good, 4: Excellent. When assessing pavement, collectors looked at the frequency and depth of cracking.
- Maintenance: Scores range from 1-3: 1: Poorly
 Maintained, 2: Maintained, 3: Well Maintained.

 When assessing maintenance, collectors
 analyzed the trail and surrounding conditions;
 whether there was trash, overgrown
 vegetation, encroachment on to the trail, etc.
- Events: When traversing the trails, collectors looked at any major hazards or items to note that should be addressed. Examples of these could be large potholes in the pavement that could cause a hazard for pedestrians.
- **Signage**: When traversing the trail, collectors looked at the signage along the trails to see if any damage is noted. These signs are included in the report for municipalities to address.


