Explanation for Requested Change:

The Town of Glenville has multiple projects progressing along Freemans Bridge Road.

In a previous CRTC meeting, PIN 176249 had TAP FLEX PE/DD funding transferred from PIN 176159 to combine the adjacent projects and reduce economies of scale. However, based on program guidance from NYSDOT Main Office, TAP cannot be combined with regular Federal Aid funding, ie. STBG. Adding additional Federal funding to TAP award affects project award ratings and ranking.

No additional funding is being requested. This TIP amendment is proposing to shift funding between existing projects per guidance received from NYSDOT Main Office. Please see the following tables describing the existing TIP and our proposed changes:
