Bridge NY 2023 – Applications by County January 30, 2024

The Transportation Council received 19 applications for Bridge NY funding. Each candidate bridge was evaluated by Transportation Council staff using the methodology approved by Policy Board in December, 2023. The tables below list candidate bridges by county, ranked from highest evaluation score to lowest. Bridges highlighted in green are recommended for funding.

Albany County (\$2,870,000 available)

Albany County was the only applicant and may receive the full \$2.87M available. The County stated that they will commit to funding the remaining amount needed for the CR 53 Bridge.
