Amendments to the 2022-2027 TIP

At its April 3, 2024, meeting, the Capital Region Transportation Council Planning Committee approved the following amendment to the Transportation Improvement Program (TIP).

1. S265, 1761.59, Freemans Bridge Road Multi-Use Path, Town of Glenville, Schenectady County & S285, 1762.49, Freemans Bridge Road Sidewalks and Multi-Use Path, Town of Glenville, Schenectady County

This amendment requests to shift \$0.280M of TAP Flex funding from PIN 176249 (S285) to PIN 176159 (S265). In February 2023 the Transportation Council approved an amendment to transfer TAP Flex funding from PIN 176159 to PIN 176249 to combine adjacent projects for improved economies of scale. However, after the amendment was processed NYSDOT Main Office provided guidance that TAP funding cannot be combined with core federal aid fund sources. This amendment will return the TAP Flex funded Preliminary and Detailed Design phases (\$0.140M each) back to their original PIN (176159). The project descriptions in the TIP / STIP were also returned to their original language.
