This amendment requests a drawdown of funds from year 2 and year 3 (FFY 2023-24 and FFY 2024-25) of the Bus Rapid Transit Setaside (CDTC31) into the Bus Plus Red Line Upgrades project (CDTC137) and into a new project for a new Bus Station and Park and Ride lot at 80 Broadway in Menands along the Bus Plus River Corridor (BRT Blue Line).

2. RG147, CRTC34, Carbon Reduction Program Set-Aside, Block Funds

At its September 7, 2023 meeting, the Transportation Council's Policy Board approved a proposal to allow Carbon Reduction Program (CRP) funds available in FFY 2023 through FFY 2026 to be used to fund cost increases to existing TIP projects that fall within the eligibility of CRP funds. With inflation and higher materials costs, it is anticipated that existing TIP projects will need additional funding. In addition, any cost increases identified during project development for TIP projects funded with TAP/CMAQ funds, which are capped, must be funded locally creating an unexpected financial burden on project sponsors and the potential for delays in project delivery.

The CRP funds in this project will be used on a "first come, first served" basis. If an existing TIP project seeks to utilize CRP funds to address a cost increase, a project amendment request will be required with Planning Committee approval, and possibly Policy Board approval, per the guidelines for TIP changes. These funds must be used in their respective urban areas per federal requirements.
