Description: The proposed scope of work would involve installation of pedestrian and bicycling enhancements, including a 10' wide asphalt sidepath, signage, and related infrastructure upgrades along Gilligan Road. There may be a reduction of crossing width at the northern EGCSD driveway, an addition of parking spots parallel to Gilligan Road, radar feedback signs at the southern and northern ends of the EGCSD property, and enhanced crossings at Gilligan Road and both Ternan Avenue intersections. Landscaping, lighting, and drainage improvements would be made as needed.

Description: The project will construct roughly 3,030 feet (2,760 linear feet on Caroline Street and 270 linear feet on Schuyler Drive) of new 5' ADA-compliant sidewalks, curb ramps, and crosswalks on one side of the street. The City will relax the 5' buffer requirement to 2 feet minimum if necessary in order to stay within the City's ROW. The twenty-seven-month construction project is scheduled to be completed in 2024. During construction, standard maintenance of traffic operations will enable all modes of travel to traverse the construction area to their destination. Residences and local businesses will have minimal and only brief delays. Conventional construction techniques will be used for the project and erosion control best management practices. The design will conform to federal, state and local standards, as well as current ADA standards.
