**Detailed Description:** Project will address a high accident location between Tallow Wood Drive and Plank Road. Reconstruct the intersection of NY 146/Clifton Country Road and rebuild the signal. Additional safety benefits would accrue from improved pedestrian accommodations, resurfacing and restriping the entire corridor. The project will incorporate ADA compliant pedestrian features. At a minimum, standard shoulder widths meeting current NYSDOT Standards will be installed.

**Roadway Functional Classification:** NY 146 is a National Highway System facility and is classified as Urban Principal Arterial Other.

**Federal Fund Source Eligibility:** National Highway Preservation Program, Surface Transportation Program, Highway Safety Improvement Program (likely)

## **Transportation Considerations:**

**Walking:** In Tier 1 Ped District but no commitment to ped facilities. **Biking:** On network, no significant improvements for bicyclists.

**Transit:** Adjacent to transit route that can't stop in left lane or on highway on-ramp.

**Motor Vehicles/Freight**: Project is located on a NYSDOT designated Qualifying and/or Access Highway and the CDTC Freight Priority Network. Project addresses a recommendation from the CDTC Freight Plan (2016); maintain a state-of-good-repair to preserve travel time and/or reliability on the CDTC Freight Priority Network (NY 146).

**Other Considerations:** Partial HSIP candidate. Highway Safety Investigation Report #1-5-0257. 2013-2018: 0 Fatalities, 3 Serious Injuries.

Advisory Committee Comments: Regional Operations and Safety - Much needed improvements for this high volume intersection with high volume turning movements. Great need for pedestrian accommodations as the Town Center development evolves on both the North and South sides of NY 146. Many new apartment units and hotel rooms have been built in this area with great need to serve pedestrian travel demand across Route 146 to the many stores, restaurants, service and office establishments. May require the incorporation of a raised pedestrian refuge island along Route 146 separating east and west travel lanes to facilitate safe and efficient N-S pedestrian travel.
