PROVIDE EXPLANATION FOR CHANGE:

The enactment of the Consolidated Appropriations Act of 2016 authorized states to repurpose certain funds, originally earmarked for specific projects more than 10 years ago, provided that: less than 10 percent of the amount made available had been obligated for the original purpose; the funds would be applied to projects within 100 miles for which the funding was originally designated; and that the repurposed projects had a strong likelihood of being obligated within three years.

The Appropriations Act provided New York with an unprecedented opportunity to repurpose idle earmarks to revitalize cities, towns, and villages by implementing transformative and innovative projects that improve mobility and accessibility by making the transportation system safer for bicyclists, pedestrians and motorists alike. NYSDOT Region 1 was the recipient of one State administered and two locally administered projects to be funded with repurposed earmark funds. Funding for this project will not count against the Regional Core Funding.

The North Greenbush project, PIN 1089.75 Bike/Ped and Streetscaping Improvements along Route 4 between the Troy City Line and the Intersection of Route 43, has been selected to receive additional repurposed earmark funding in the amount of \$5.880M. The scope of the proposed project will redesign the existing Route 4 and

Williams Road /Glenmore Road intersection to improve traffic safety and flow and enhance bike/ped and streetscape needs (sidewalk/pathway, illumination, stripped bike paths, signalized pedestrian crossways, etc.) in the project area. Preliminary engineering seems to favor a roundabout design with center turn lanes for the project area but all feasible alternatives will need to be examined.
