All letters requesting TIP amendments are considered “draft” and must be reviewed and approved for completeness and accuracy by CDTC staff. This includes significant coordination between CDTC, the project sponsor, and NYSDOT. TIP amendments examples are found in the TIP document on our website.

* *This meeting is optional, but members are strongly encouraged to attend. The purpose of the meeting is to highlight the proposed changes in the draft New Visions 2050, for which we will request approval to release to the public at the February 6, 2020 Planning Committee meeting. CDTC staff program managers will give 5-10 minute presentations for each of the 12 chapters in New Visions 2050, answer questions, and address comments.
