RE: NYSDOT PIN 1760.84 TAP/CMAQ RENSSELAER RIVERFRONT MULTI USE TRAIL (CITY OF RENSSELAER, RENSSELAER COUNTY)

Dear Ms. Misiewicz:

We are submitting the proposed amendment to the 2022-2027 Transportation Council TIP on behalf of the City of Rensselaer for consideration by the Planning Committee at its next scheduled meeting.

PROVIDE EXPLANATION FOR CHANGE:

The project to construct a Multi-use Trail along the Hudson Riverfront has updated the project limits from the original DeLaet's Landing to Riverfront Park in the City of Rensselaer. The updated project limits are now DeLaet's Landing to the Hilton Park and Boat Launch, and will now be constructed in phases. The first phase will commence construction in FFY 24-25 and the second phase is anticipated to be constructed in FFY 26-27.

The limits are as follows:

- Phase 1: Construct a Multi-use path from Delaets Landing to the Amtrak Bridge Approach. (Constructed by NYSDOT)
- Phase 2: Construct a Multi-use path from the Amtrak Bridge Approach to Hilton Park and Boat Launch. (Constructed by City of Rensselaer)

The change below reflects the addition of a new funding source for construction and a phase shift to FFY 26-27. The new fund source Carbon Reduction Program (CRP) Flex will not count against regional or MPO Planning Targets. The addition of funds represents an increased cost of construction identified during preliminary design combined with inflation due to the deferral of construction from the original anticipated timeframe.

The New York State Department of Transportation will construct Phase 1 of the Multi-use trail while the City of Rensselaer will construct Phase 2.
